#### (a) UN, UNECE and subsidiary bodies

### 3. Revision of UNECE standards<sup>1</sup>

#### (a) Truffles

At the November 2015 session of the Working Party, the delegation of France requested further discussions on the English version of the revised non-exhaustive list of commercialized truffles to be included in the UNECE Standard for Truffles. The Working Party therefore decided to return the proposal to the Specialized Section for review.

#### (b) Garlic

At the November 2015 session of the Working Party, the delegation of Sweden expressed concern about the tolerances for physiological damage included in the proposed new text of the standard. The Working Party therefore decided to return the proposal to the Specialized Section for review.

In addition, the 19th Session of the Codex Committee on Fresh Fruits and Vegetables (CCFFV) which took place in Mexico in October 2015, decided to recommend to the

Codex Alimentarius Commission to advance the standard for garlic in the Step Procedure to be finalized at its next session<sup>2</sup>

**(c) Headed Cabbage**

At the April 2015 session of the Specialized Section on Fresh Fruit and Vegetables, the Specialized Section decided to review the UNECE Standard for Headed cabbage with a focus on the issue of running to seed.

**(d) Table Grapes**

At the April 2015 session of the Specialized Section on Fresh Fruit and Vegetables, the Specialized Section decided to review the UNECE Standard for Table grapes with a focus on the tolerance for loose berries.

**(e) Annonas**

The delegation from Costa Rica asked the Specialized Section to review the sizing provisions for Soursop and include size codes for large produce.

**(f) Sweet Peppers**

**(h) Leeks**

At the April 2015 session of the Specialized Section, delegates decided to review the UNECE Standard for Leeks and take into account the work on an explanatory brochure by the Organisation for Economic Co-operation and Development (OECD) for this product. In addition, delegates decided to examine the UNECE Standard for Leeks in an attempt to identify possible areas of food loss/waste caused by the application of the standard. Delegations are invited to send proposals for amendments to the Secretariat.

**(i) Citrus fruit**

At the 2015 session of the Specialized Section, the delegates decided to postpone discussions on the amendment of the standard to the 2016 session. The changes proposed by the delegation from South Africa are included in the new document together with an informative (non-exhaustive) list of varieties which is intended to be published as a separate document on the UNECE website.

**(j) Apples**

At the 2015 session of the Specialized Section it was decided to ask all delegations to send to the secretariat a list of those varieties that are of commercial importance to their countries. The list presented in the document was compiled by the secretariat on the basis of contributions received from delegations.

**(k) Aubergines**

At the 19th session of the Codex Committee on Fresh Fruits and Vegetables (CCFFV) which took place in Mexico in October 2015, it was decided to recommend to the Codex Alimentarius Commission to advance the standard for aubergines for final adoption (June 2016).<sup>3</sup> In an effort to harmonize the provisions, the Specialized Section is invited to compare the two texts.
